- Going forward Jeremy believes we need to think less as individuals and more as a cohesive group to enable Northland to succeed.
- With this is mind Jeremy elaborated on the work done this year by the Board around the 4
 Pou essentially NorthChamber four key areas of focus: advocacy, ease of business,
 networking and leadership
- Personal highlights for Jeremy this year included the Hall of Fame award presented to the Kaka Porowini for his contribution to business and recognition of their mana. His story is not only inspirational for Maori but also Northland business as a whole.
- BA5s remain really successful and Jeremy pointed out how great it is to see regulars and new
 members and how doing business over a beer or juice is never a chore. He also thanked our
 many stakeholders, national and regional partners whose support for NorthChamber and the
 Board makes our operations run so much smoother here in Northland.
- Finally Jeremy congratulated the new President elect Tim Robinson and the new Board members Trevor Griffiths, Tony Savage and Mike Kanji and felt confident the Chamber was in very safe and competent hands going forward.

Financial Report

Treasurer's Report – year ended 31 December 2019 Danny Douglas spoke to the financial statement for 2019

Profitability

The Chamber has reported a net loss of \$17,914 for the year compared to profit of \$7,914 in 2018. In this challenging time want to thank the hardwork from all the staff Steve, Janette, Rebecca, Paulette and Niamh have all done in a tough year.

Revenue

Overall revenue held fairly steady and was down to \$210k from \$217k in 2018 that is in line with 2017

Changes in revenue streams:

- Business awards up 5.5k to \$26,370 from \$20,714 in 2018, costs were steady ticket sales, sponsorship was up,
- Business Mentors was down approximately \$3,500
- Membership subscriptions was steady at 112k. Membership total at 481 compared to 488 in 2018
- Whangarei maps up by 1.5k
- The Business Mix and Future crunch events made a combined loss of 3.2k compared to 4.8k of additional income last year, this was mainly down to a late withdrawal of a sponsor of approximately 3k and lower than expected ticket sales
- The main reduction income was the unexpected loss of the regional business partners contract that was unforeseen and is supplementary to the work we are still doing that we are now not compensated for this was a \$11,667 reduction
- Sponsorship was up and it is great we still received great support from Vodafone,
 OfficeMax, Noel Leeming being the main alliance partners.
- Our major gain in income this year was down to the Ministry of Social Development work that has been done on the Whangarei CBD, I would like to thank the MSD for the support and assistance they have given us this year and the ongoing future relationship that is helping with events like the Job lab

Expenses

Total expenses were up by approximately \$17k. The major area wAS staff remuneration., vehicle expenses. Most other expenses have resulted in similar costs to prior year or slight increase over the prior year. The big rise in vehicle costs and subsequently FBT on the vehicle are from the Lease of a vehicle for chamber use, with Steve and the team trying to get around more to the wider Northland business community the additional reimbursement costs were largely replaced by the lease of new vehicle.

Financial position

As at 31 December the Chamber held \$110K of assets made up of:

Bank balances \$31.5k down from 79k prior year

Debtors \$39.5k up from \$26k

Equip \$9.5k includes cost of the Chamber share of Orchard fitout

Total Assets \$110K

Less Liabilities \$39.5k – suppliers and IRD, income in advance

Giving Accumulated Members Fund \$71k down from 88k

Future Focus

- continue to expand revenue streams, as shown by MSD assistance and CBD developments,
- Utilise funds to continue to develop services
