## **TEAM RECOMMENDATIONS/REPORTS:**

### **Ease of Business:**

- Meeting was had 3<sup>rd</sup> July, meeting notes were tabled.

The recent earthquake started another discussion on how to attract new businesses to Northland and how we could capitalize on the fact that we are still 'open for business.' Vince has spoken to businesses and said that the general consensus was that the Northland lifestyle was what attracted people to move North.

It was also mentioned that the Northland INC sector marketing video was released that there was still dissatisfaction from some sectors over the message portrayed.

The question of statistics on the ratio of new businesses versus growth of existing businesses was raised in Northland too.

A/P: Ryan to contact call centre in Wellington to ask if they considered Whangarei as a viable option

A/P: Each Board member to ask customers what they see are the advantages of living/doing business in Northland are - perhaps that could be a mayoral candidate question.

A/P: Tony to check with Darrel Jones at NRC as to statistics/figures available about business numbers.

# Advocacy/Membership Action Group:

Meeting notes were tabled.

Another issue raised is the current effect the change of the Air NZ planes is creating with passengers being 'bumped off' due to weather conditions. Tony advised that he has a meeting arranged with Air NZ and WDC on the 12th of August to discuss these issues. The question of whether a competitor being present would alleviate the problems.

A/P: Tony to write to Jetstar to see if viable option for them to start domestic services in and out of Whangarei.
